On January 11, 2024, the MBA Department organized a Guest Lecture for final-year MBA students (Batch 2022 – 2024). The session was facilitated by Dr. S. Srinivasa Rao, Associate Professor, Department of Commerce and Business Management, TJPS College, Guntur. With a teaching portfolio encompassing subjects like Financial Management, Security Analysis and Portfolio Management, Financial Derivatives, and Accounting for Financial Management, he is currently engaged in instructing MCom students. Additionally, he provides research guidance to M.Phil and Ph.D. scholars in Management and related disciplines. Dr. Rao's research interests lie predominantly in Commerce.
